



THIS IS THE LAST WILL AND TESTAMENT of me CATHERINE HEMINGWAY of

52 Thorpe Lane Tingley Leeds whereby I revoke all previous Wills and testamentary dispositions

1. I APPOINT my brother James Cannon and my niece Agnes Fryer to be Executors and Trustees of this my Will

2. THE expression "my Trustees" in this my Will shall mean and include the Executor or Executrix or the Executors and the Trustee or Trustees for the time being hereof whether original or substituted

3. I EXPRESS the wish that my funeral service shall be held at St. Francis Church Morley Leeds and that Mr. Peter Scanlan of Highmoor Road West Ardsley Leeds be requested to play the organ at my funeral service and I DESIRE that my body shall be buried at Bruntcliffe Cemetery in the space reserved for the purpose in the grave of my late husband Robert Hemingway

4. I DIRECT my Trustees to set aside and pay from my estate such sum as they shall in their absolute discretion deem sufficient to meet the costs of providing and installing a stained glass window depicting Our Lady Queen of Peace at St. Francis Church Morley Leeds to be dedicated to the memory of myself my late husband Robert Hemingway and my late parents James and Agnes Cannon and I DIRECT my Trustees to apply such sum from my estate for that purpose as soon as may be practicable following my death

5. I GIVE the following free of all duties and taxes:-

(a) the sum of Two hundred and fifty pounds each to each of the parish priests of St. Francis Church Morley Leeds at the date of my death

(b) the sum of Five hundred pounds to The Congregation of the Sisters of the Cross and Passion for the purposes of building equipping and maintaining St. Gemmas Hospice of 329 Harrogate Road Leeds

(c) the sum of Five hundred pounds to the Diocese of Leeds to be used so far as may be practicable for the benefit of the Priests Training Fund and subject thereto for the general purposes of the Diocese

(d) my wine trolley to the Reverend Bernard Ratlidge of Westfield Road Morley Leeds

(e) all my jewellery to my great-niece Rachel Fryer of Oakroyd Thorpe Lane Tingley Leeds

(f) all my personal chattels as defined by Section 55(1)(x) of the Administration of Estates Act 1925 not otherwise specifically disposed of by this my Will or any Codicil hereto to my niece Agnes Fryer of Oakroyd Thorpe Lane Tingley Leeds

6. I DEVISE AND BEQUEATH to my Trustees all my real and personal estate not specifically devised or bequeathed by this my Will or any Codicil hereto UPON TRUST to sell and convert the same into money with power to postpone sale and conversion for such period as my Trustees may think proper and out of the proceeds to pay or provide for my debts and my funeral and testamentary expenses and any pecuniary legacies or annuities and all duties and taxes payable on any devise or bequest given free of taxes by this my Will or any Codicil hereto and my Trustees shall divide the ultimate residue ("my residuary estate") into four equal shares and shall hold the same upon the following trusts:-

(a) as to one such share for my said brother James Cannon absolutely

(b) as to one such share for my brother John Cannon absolutely but if he shall predecease me then for such of his children as shall be living at my death and if more than one then equally between them

(c) as to one such share for my said niece Agnes Fryer absolutely but if she shall predecease me then for such of her children as shall be living at my death and if more than one then equally between them

(d) as to one such share for the said Reverend Bernard Ratlidge absolutely

7. IF the trusts of any share bequeathed by Sub-Clauses (a) to (d) inclusive of Clause 6 of this my Will shall fail by reason of no person's attaining a vested interest thereunder THEN I DIRECT that the said share and any share or shares which may accrue thereto by virtue of this provision shall accrue and shall be held as an accretion to the other share or shares the trusts whereof shall not at the date of such accruer have failed and if more than one in the proportions which the original shares bear to each other

8. (A) I DIRECT that if before my death (or after my death but before my Trustees have given effect to the gift in question) any charitable or other body to which a gift is made in this my Will has changed its name or has amalgamated with or transferred all its assets to any other body then my Trustees shall give effect to the gift as if it had been made (in the first case) to the body in its

changed name or (in the second case) to the body which results from such amalgamation or to which the transfer has been made

(B) I DIRECT that the receipt of the Treasurer or other proper officer for the time being of any charitable or other body to which a gift is made in this my Will shall be a good and sufficient discharge to my Trustees

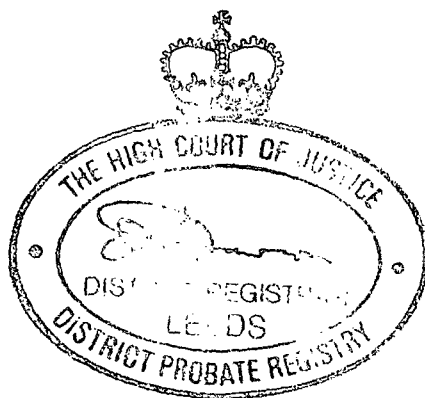

THIS IS THE FIRST CODICIL to the Will of me CATHERINE HEMINGWAY of 52 Thorpe Lane Tingley Leeds which Will bears date the Tenth day of October One thousand nine hundred and eighty six

1. I REVOKE Clause 4 of my said Will

2. I REVOKE Sub-clause (a) of Clause 5 of my said Will and substitute the following Sub-clause in lieu thereof:-

" (a) (i) the sum of Two hundred and fifty pounds to the Parish Priests of St. Francis Church Morley Leeds for the saying of masses

(ii) the sum of Two hundred and fifty pounds to the Reverend Bernard Ratlidge for the saying of masses

3. IN all other respects I confirm my said Will
