Lytham St. Annes Lancashire solicitor the sole Executor named in the said Will.

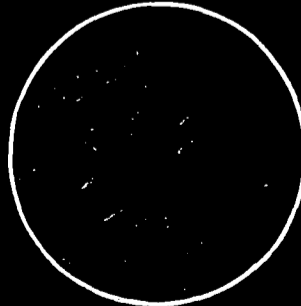
